WAY FORWARD:



Shift from individual capacity development to institutional issues-focused capacity development of the countries



Support finalisation, endorsement and implementation of the **Iraq National IBM Strategy and Action Plan**



Development of FIA border control capacity including information exchange, inter-agency cooperation and operational procedures at air border crossing points

Note on Afghanistan:

Prior to summer 2021 and deterioration of the security situation in the country, the draft National IBM Strategy and Action Plan were finalised through a round of inter-ministerial workshops and bi-lateral meetings

of the inter-agency working group, which included ten border-related ministries. The IBM Strategy was handed over to the Ministry of Foreign Affairs by the project in May 2021.
